ACT 172 LOCAL TAX CREDIT - VOLUNTEER FIREFIGHTERS

A discussion regarding Act 172 which allows municipalities to grant tax credits on Earned Income or Property Taxes to active volunteer firefighters. The tax credit can be up to 20% of the liability. At this time the Bridgeville Volunteer Fire Department has 20 active members.
